This letter sets forth the agreement (“Agreement”) between RV/Motorhome Dealer

[Company Name]

(“Company”) and General Motors LLC (“GM”) regarding Company’s claims for payments under the GM 2019 MY RV/Motorhome Dealer Rental Fleet Tiered Volume Incentive Program (“Program”).

The terms and conditions of this Agreement are as follows:

1. GM 2019 MY RV/Motorhome Dealer Rental Fleet Tiered Volume Incentive Program (“Program”)

- (a) GM sells Chevrolet Express and Silverado Medium Duty 2019 Model Year cutaways and chassis cabs (Vehicles) to certain RV/Motorhome manufacturers who have the GM Manufacturer Incentive Agreement (“MH Agreement”) with GM to purchase Vehicles for manufacture of Class C RV/Motorhomes.

The current listing of RV/Motorhome manufacturers under the MH Agreement with GM is:

- (b) Company will purchase RV/Motorhomes manufactured from one of these RV/Motorhome manufacturers for RV/Motorhome Rental Fleet Service.
- (c) Company will enroll the Vehicle(s) into the Program and claim tiered volume incentives for its RV/Motorhome Fleet vehicles. All claims must be made using the attached form.

2. Company agrees to retain any documents or records relevant to the RV/Motorhomes purchased for RV rental use and for which incentives have been claimed for payment under this Agreement for two years after the close of the Program. Company will permit any designated representative of GM to examine, audit and take copies of any accounts and records Company is required to maintain under this Agreement. Company will make such accounts and records readily available at its facilities during regular business hours upon reasonable advance notice. GM will furnish Company with a list of any reproduced records.
3. Company will not rent, lease, sell or otherwise dispose of any vehicles that are the subject of a safety or non-compliance campaign or recall unless or until the necessary repairs have been made.
4. This Agreement and its attachments represent the entire agreement regarding the subjects herein between Company and GM and may be modified only in a writing executed by an authorized representative of each of the Parties.
5. This Agreement will, in all respects, be interpreted, enforced and governed under the laws of the State of Michigan, without regard to the conflicts of law principles thereof.
